- To help pupils develop interest in analytics of new age public finance.

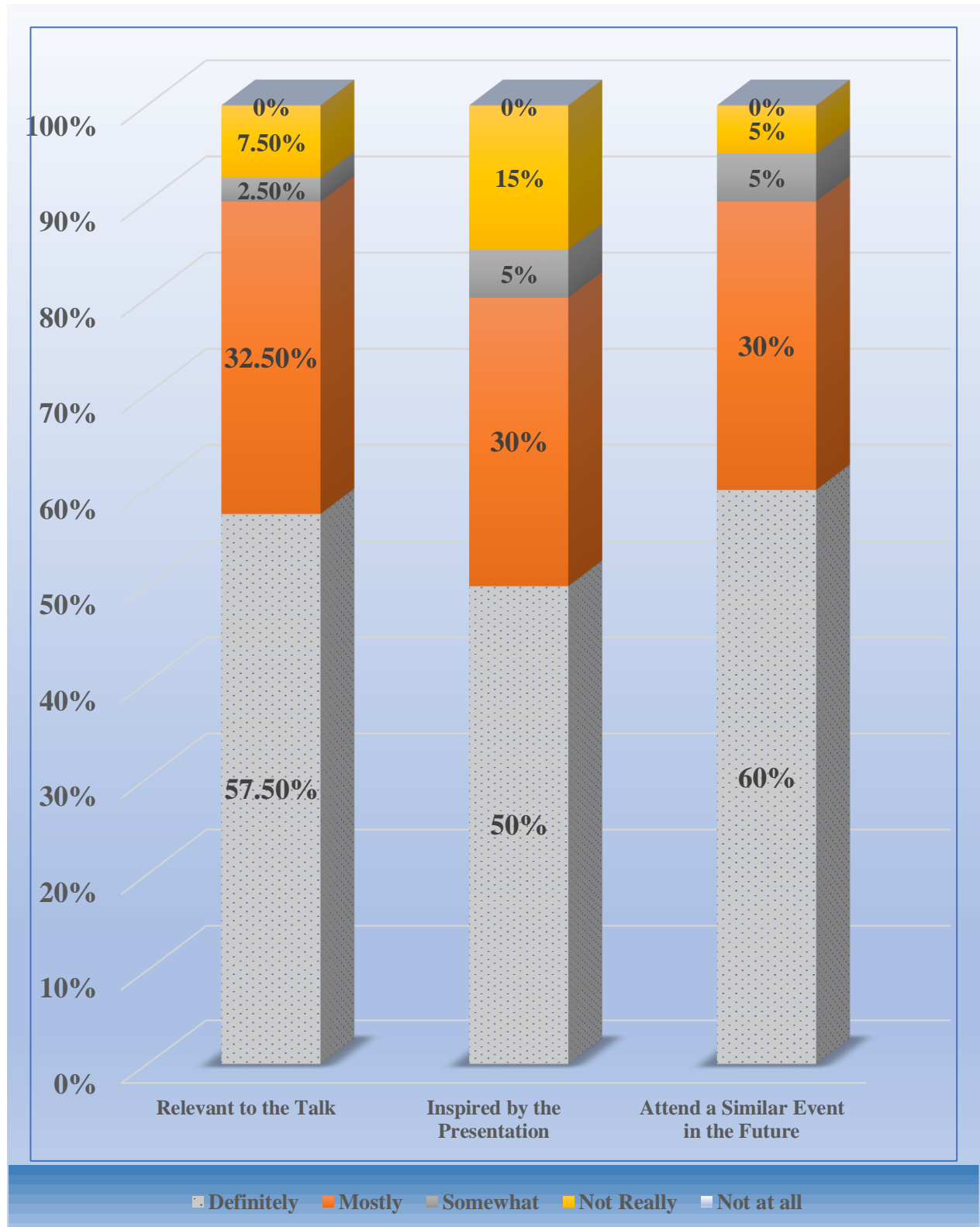
Learning Outcomes:

2. To instil awareness among the students regarding cause and deterioration of air quality and ecological loss.

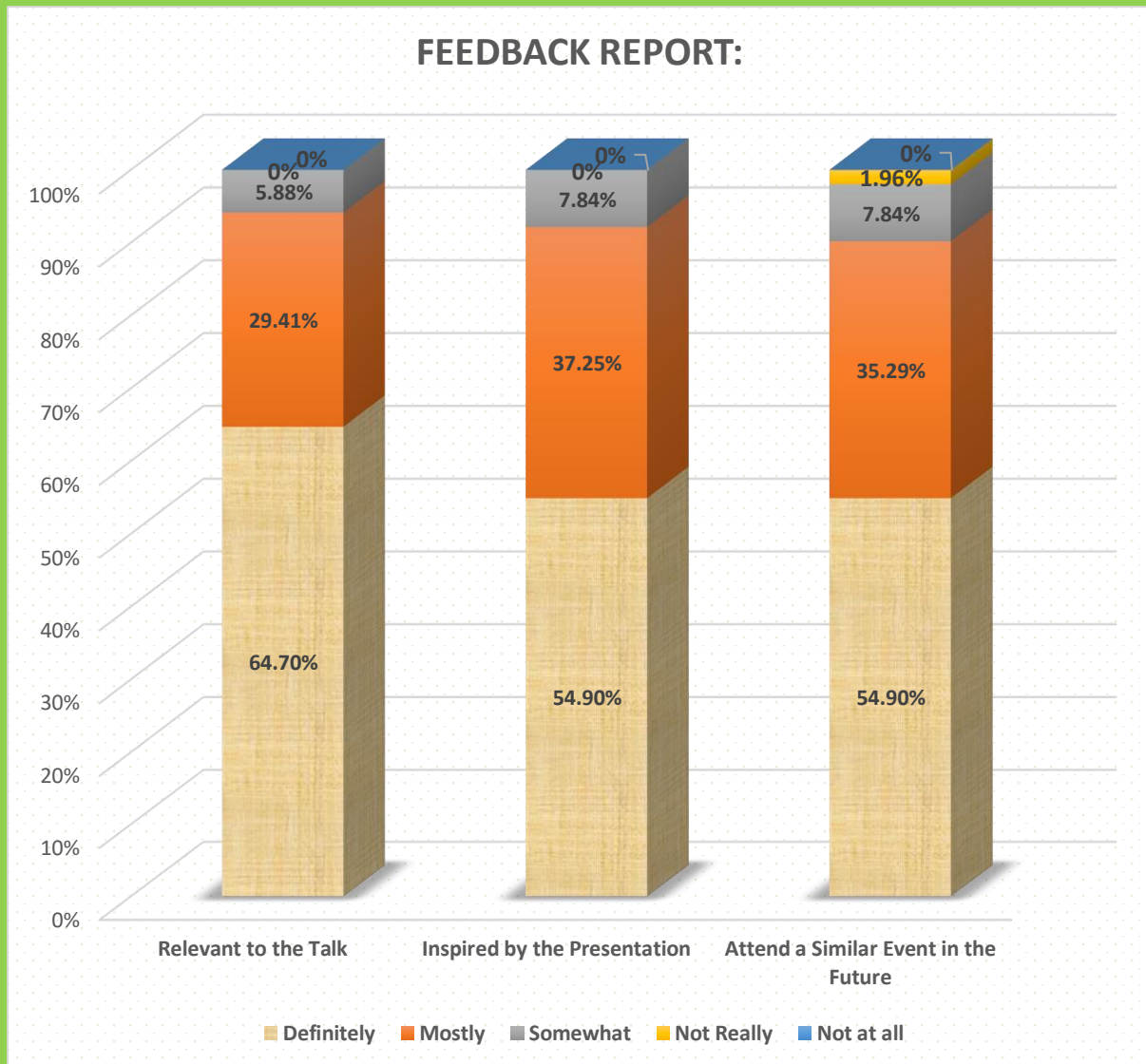
Learning Outcomes: -
