- · Rising number of domestic violence
- · Incidents of intensifying untouchability
- · Livelihood of the transgender community
- · Role reversal for women at household domain during the lockdown
- · Female workforce belonging to the unorganized sector

Submission Guidelines and Details:

The paper must primarily focus on highlighting the current conditions of the selected topic; possible suggestions for arrangements and illustrated with the help of Case Study. Prospective contributors MUST rely on secondary data and preliminary observations only. There will be **zero tolerance towards plagiarism**; include appropriate citations. Contributors can submit papers individually or in a group of 2-3, mentioning each contributors name and department clearly.

Prospective contributors should submit a paper of 1,500 words, inclusive of supplemental materials (such as tables, figures, references, etc.). Text must be in 12-point, Times New Roman font, and all submissions must include 1-inch margins on all four sides, with pages numbered sequentially at the bottom center. Submissions should be prepared using the APA Style Guide. The papers will be sent to the jury for review and upon selection best papers will be published in the College e-Journal.

Proposed paper submissions should be mailed as a single PDF and received no later than 5 pm on **June 20, 2020** to <u>loretocollegehrsocio@gmail.com</u>.

Learning outcomes:

The co-organizers received a total of 12 papers that had both single-authored and coauthored (not more than 03 authors) papers. The final selection of three best papers was done by esteemed Jury Members from our college.

Some of the themes that students submitted their papers included Economic and labour-market consequences of COVID-19; Rising number of domestic violence; Livelihood of the transgender community; Social distancing and potential exposure among vulnerable populations (homeless persons, disabled individuals, the elderly, street children, migrant labourers, etc.) and Female workforce belonging to the unorganized sector.

Students who had written the three best papers were taught the nuances of writing and formatting a research paper through several virtual meetings. The three best papers were included in the College e-Journal.

Learning objectives:

The objective of this Sociology Web-talk was to illustrate the necessity to study the history of the discipline before the students. Thereby to enable an understanding of the present and future trajectories, and configurations of Sociology. Through this overview of history of Sociology students are encouraged to understand why what happens in Sociology.

Learning outcomes:

Our invited speaker Mr. Rakesh M. Krishnan addressed the Loreto College students who are attending as well as have attended Sociology Elective courses in the last two years. Around 87 students had registered for the Web-talk, out of that we saw a turnout of 70 students on the day of the presentation. The students were made aware of the historical background of the discipline of Sociology through this Web-talk. This helped them understand the foundation of the disciplines in a much detailed way beyond the purview of the course. They were also introduced to the Southern Theory approach as an alternative way of looking at the history of the discipline.
